A tax rate of \$0.100000 per \$100 valuation has been proposed by the governing body of Harris County Emergency Services District No. 47.

The no-new-revenue tax rate is the tax rate for the 2023 tax year that will raise the same amount of property tax revenue for Harris County Emergency Services District No. 47 from the same properties in both the 2022 tax year and the 2023 tax year.

The voter-approval rate is the highest tax rate that Harris County Emergency Services District No. 47 may adopt without holding an election to seek voter approval of the rate, unless the de minimis rate for Harris County Emergency Services District No. 47 exceeds the voter-approval rate for Harris County Emergency Services District No. 47.

The de minimis rate is the rate equal to the sum of the no-new-revenue maintenance and operations rate for Harris County Emergency Services District No. 47, the rate that will raise \$500,000, and the current debt rate for Harris County Emergency Services District No. 47.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that Harris County Emergency Services District No. 47 is proposing to increase property taxes for the 2023 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 21, 2023 AT 7:00 pm AT Westlake-ESD 47 Fire Station; 19636 Saums Rd.; Houston, Texas 77084.

The proposed tax rate is greater than the voter-approval tax rate and the de minimis rate. If Harris County Emergency Services District No. 47 adopts the proposed tax rate, Harris County Emergency Services District No. 47 is required to hold an election so that the voters may accept or reject the proposed tax rate. If a majority of the voters reject the proposed tax rate, the tax rate of the Harris County Emergency Services District No. 47 will be the voter-approval tax rate. The election will be held on November 7, 2023. You may contact the for information about voting locations. The hours of voting on election day are .
