<u>NOTICE OF REGULAR MEETING</u> CONDUCTED IN PERSON AND ELECTRONICALLY

TO: THE BOARD OF FIRE COMMISSIONERS OF EMERGENCY SERVICES DISTRICT NO. 47 IN OF HARRIS COUNTY, TEXAS, AND TO ALL OTHER INTERESTED PERSONS:

A governmental body may hold an open meeting by telephone conference call or video conference if: (1) an emergency or public necessity exists within the meaning of Section 551.045 of the Texas Government Code; and (2) the convening at one location of a quorum of the governmental body is difficult or impossible. The current COVID-19 pandemic and the public proclamations by federal, state, and local governmental officials in 2020 ordering persons to stay at home and prohibiting certain gatherings of people constitutes both an emergency and a public necessity.

Notice is hereby given pursuant to Government Codes Section 551.001, 551.045, 551.054, and 551.125, as amended, that the Board of Commissioners of Harris County Emergency Services District No. 20 will hold its regular monthly meeting, open to the public, at <u>7:00 p.m. on Thursday, October 15, 2020.</u> Because of health concerns and social distancing requirements, Commissioners and members of the public who wish to participate in the meeting, have the option to participate either in person or via telephone conference call.

For persons desiring to attend the meeting in person, the meeting will be held at the District Fire Station located at <u>19636 Saums</u>, <u>Houston</u>, <u>Texas 77084</u>, inside the boundaries of the District.

Persons desiring to participate in the meeting may access the telephone conference call by <u>calling 346-248-7799</u> and entering the meeting id: 891 5543 4392 when prompted to do so.

As a courtesy, and only as a courtesy, Commissioners and of members of the general public may also participate in the meeting via Zoom video conference (using the video provisions of Section 551.127 of the Texas Government Code) by going to the

following internet site on a computer, tablet, iPad, smart phone, or other mobile device: https://us02web.zoom.us/j/86804062425; however, the designated and primary methods for participation is either in person at the District's Fire Station or by telephone conference call pursuant to Chapter 551.125 of the Texas Government Code.

In accordance with Section 551.125 and 551.127, the meeting will be recorded; and a copy of the recording will be available to the general public within a few days after the teleconference ends.

At this meeting of the District, which is open to the public, the Commissioners will consider and act upon the following matters:

- 1. **Confirmation of Emergency Status.** Discussion of current events to determine whether or not an emergency exists and to confirm compliance with applicable statutes for open meetings and for emergencies.
- 2. **Review Electronic Meeting Protocols.** Discuss provisions of Texas Government Code 551 and associated requirements for open meetings held via telephone conference and via video conference.
- **3. Public Comment:** To receive comment from members of the public (By District policy, speakers under this item are limited to five minutes for their presentation and comments, whether their intended comments relate to an identifiable item of business on this agenda or to other matters).
- **4. Minutes from Prior Meetings.** Review and approve minutes from prior meetings, including minutes prepared for meetings held in whole or in part using electronic, video, or telephonic means.
- **5. Sales and Use Tax Report:** Review report on sales and use taxes, including submission of required documents to the Texas Comptroller and other entities; approval of other costs and filings associated with the sales and use tax process; and other related issues.
- **6.** Clarification of Contract with Sales and Use Tax Consultant: Review and discuss the start date of Contract with Sales and Use Tax Consultant approved at the District's meeting on June 24, 2020, including amendment to said contract if appropriate.
- 7. Financial and Bookkeeper's Report: Review and approve the finances of the

District, the bookkeeper's report, the investment report, the payment of bills, and the payment of compensation to Commissioners; authorize all appropriate action related thereto, including but not limited to additional allocation of funds and/or ratification of checks issued and funds expenditures since last meeting.

- **8. Westlake Fire Department Report:** Receive and review the contractually required report from Westlake Fire Department officials regarding activity in the District and the Department's financial status, and authorize all appropriate action, if any, including but not limited to the additional allocation of and/or ratification of the expenditure of additional funds for unexpected or emergency expenses.
- **9. Review Applicable Laws Related to Sale of District Assets:** Review and discuss applicable laws and statutes governing the sale and disposal of District assets, authorize sales of District assets and allocate funds as deemed necessary and/or appropriate.
- **10. Full Time Paid Ambulance Crew:** Consider and discuss adding a paid ambulance crew to have in service during those hours not already covered by a paid ambulance crew or crews. Amend the Westlake year 2021 budget and/or the District's year 2021 budget if deemed necessary and/or appropriate.
- 11. Consider Purchasing Additional Fire and Emergency Equipment and/or Vehicles: Consider and discuss the purchase of one or more vehicles and associated equipment for such vehicle, including but not limited to ambulances to be used by Westlake to perform emergency medical services; authorize purchase and allocate funds as deemed necessary and/or appropriate in accordance with applicable purchasing rules and requirements.
- 12. Traffic Signal Pre-Emption System: Consider and discuss the implementation of a system that controls traffic at intersections in the path of a responding emergency vehicle; take any action deemed necessary and/or appropriate including the allocation of funds.
- 13. Katy Area Safety Fest. Consider and discuss the District's participation in the 2020 Katy Area Safety Fest; take any action deemed necessary and appropriate including the appropriation of funds.
- **14. Amend District 2020 Budget**. Review and discuss District's 2020 budget and make amendments as desired and/or appropriate.
- 15. Amend District's 2021 Budget. Review and discuss District's 2021 budget and

make amendments as desired and/or appropriate.

- 16. Attorney's Report: Receive a report from the District's Attorney and authorize all appropriate action, including but not limited to reviews of the District's contracts with consultants and review of any applicable laws, rules, regulations, and statutes.
- 17. Other: Such other matters that may come before the Board and authorize appropriate action.
